Category	Announcement of Legal Change

Symptom

This SAP Note contains information about the legal change in **Social Insurance** due to the new way of reporting contributions to treasury/social insurance.

The General Treasury of the Social Security (Social Security Fund) has been working last years in the new system of direct settlement quotes (Cret@ Project) to Social Security, which will allow itself to take an active role in the collection process, from a reverse billing ("autoliquidación") model and provide more information on contributions to companies and workers through a personalized multi-channel model of care.

The main objectives of the project are: minimize errors by assuming the Social Security Fund applying the listing rules and compare the data with pre-settlement character and improve transparency and relationship with companies based on telematic system and removing completely paper and onsite actions.

This new system involves amendments to the current procedure of exchange of information, treatment, structure and format of the files to the users of the RED System relate to the Social Security Fund.

Solution

This document is on the Seguridad Social website under *Sistema RED » Sistema de Liquidación Directa (Proyecto Cret@) » Documentación » Manuales de Usuario*.

2.2) **SAP Note 2044174** is released with advises to the Next Month treatment (Mes Diferido) according to the definitions of chapters 1.2.5 "*Situación IT diferida Contingencias comunes pago delegado (PEC 25: mes actual /PEC 26: mes anterior)*" and 1.2.6 "*Situación IT diferida AT y EP pago delegado (PEC 27: mes actual / PEC 28: mes anterior)*" on the document "*Datos a remitir para la cotización L00*" (version date 06.05.2014). This document is on the Seguridad Social website under *Sistema RED » Sistema de Liquidación Directa (Proyecto Cret@) » Documentación » Manuales de Usuario*. The **SAP Note 2053577** is released with adjustments to source code of *Social Insurance contribution models (RPCTC0E0)* report and *Spanish payroll (RPCALCE0)* report.

3) **SAP Note 2052995** is released with the adaption of **Cret@: fichero de bases** (RPC_PAYES_CRETA_BASES) report to read payroll data from the **PCL4** cluster when using "**Periodo desfasado**" functionality.

4) **SAP Note 2128689** is released with the new **Cret@: Procesamiento de ficheros** (RPC_PAYES_CRETA_FILES) report to treat the Cret@ XML response file.

5) **SAP Note 2119423** is released with the new **Cret@: Ficheros de Solicitud** (RPC_PAYES_REQUEST) report generates *Solicitud de borrador, Solicitud de calculos, Solicitud de confirmación, and Solicitud de trabajadores y tramos* XML files.

6) Update on documentation, IMG, and programs' names to "Sistema de Liquidación Directa (SLD)" instead of "Cret@". Planned delivery date is *June 11, 2015* only via HR Support Package.

7) **SAP Note 2149093** is released with the enablement of Ejecución productiva (P_LIVRUN) field in **SLD: fichero de bases** (RPC_PAYES_CRETA_BASES) report allowing to store payroll data into PCL4 cluster when using "Periodo desfasado" functionality.

8) **SAP Note 2174204** is released with improvements on "SLD Procesamiento de ficheros" tool with new features in RPC_PAYES_CRETA_FILES report to support the processing of "**SLD-Fichero de Calculos**" file.

The development consists in a set of tools for managing the SLD files processes, including the new **Gestión de Estados** (3393) Infotype and a program to search, view, and change statuses for each employee processed.
