Symptom

This SAP Note contains information about the legal change in **employee taxes for 2016** due to "*Real Decreto-ley 9/2015, de 10 de julio, de medidas urgentes para reducir la carga tributaria soportada por los contribuyentes del Impuesto sobre la Renta de las Personas Físicas y otras medidas de carácter económico, (B.O.E de 11 de julio)*".

Solution
