Symptom

The following symptoms have been identified in the **SLD: fichero de bases** (RPC_PAYES_CRETA_BASES) report:

1. A **Complementaria por vacaciones no disfrutadas** (L13) liquidation containing only a **Modalidad de Salario** (51) indicator might be incorrectly generated when the employee combines legal guardianship and absences in the same month, even when there are no **non-taken vacations** (VND) to be reported.
2. You run the report with the **Ejecución productiva** (P_LIVRUN) checkbox selected. Some payroll results are selected but are not reported in the Bases file. To ensure the consistency of the lagged period functionality, those results should be saved in the **Directorio de resultados de nómina utilizados en el TC** (T5EC1), but they are not.
3. When running the report for several employees, a TIME OUT error is occurring due to the long processing time.
4. You run the report for an employee with legal guardianship hours, and one of the following error messages are returned by the Social Insurance in the response file: "**BASES AT. INFERIOR AL MINIMO**" or "**BASES C.C. INFERIOR AL MINIMO**" (C9626).

Reason and Prerequisites

You have to apply the SAP Note 2259986, which delivers the new class responsible to access the **Campos relevantes por aplicación** (T77PAYES_RELAP) table.

You have to apply the SAP Note 2256985, which delivers the new method SET_CCC_RANGE method for the **Clase para filtro de CCC** (CL_HRPAYES_CCC_FILTER) utility class in order to help applying the **Código de Cuenta de Cotización** (CCC) filter.

1. The report initially adds intervals to an L13 liquidation in order to report legal guardianship hours, which might take to the creation of the I51M indicator as well. Afterwards during the processing, these hours are correctly removed. However, the I51M indicator remains by mistake.
2. This symptom may happen in different situations, for instance:
 - o An unpaid absence during the whole month
 - o A total strike during the whole month
 - o In a month with more than one payroll splits, an additional settlement when there are no difference to report in one of those splits
3. The RPC_PAYES_CRETA_BASES was reading the T77PAYES_RELAP table several times for small groups of data.
4. The RPC_PAYES_CRETA_BASES was not considering the **Permiso sin Sueldo** (SR01) wage type when calculating the **Horas trab. sin decimales** (/3CR) and the **Horas trabajadas en contratos a tiempo parcial** (/3CS) wage types.

Solution

1. The report avoids adding legal guardianship hours to L13 liquidations. As a consequence, no I51M indicators are created for this liquidation.
2. Payroll results that were correctly selected but not used to generate the Bases file are now saved in the T5EC1 table.
3. The procedure responsible to read the T77PAYES_RELAP table has been changed in order to avoid unnecessary access to the database.
4. The **Horas trab. sin decimales** (/3CR) and the **Horas trabajadas en contratos a tiempo parcial** (/3CS) wage types are updated in the **Asignación CC-nóminas a CC-nóm.acumulación** (V_T596I) view to consider the **Permiso sin Sueldo** (SR01) wage type.

Version	Date	Reason
15	20.05.2016	No changes have been made for the releases 600 and 604. For the release 608, the creation of the method get_ccc_range of the class lcl_ccc has been included in the correction instruction. This method has been already delivered by the HR SP 25. This change does not affect the functionality of the report and is only being delivered by SAP Note to avoid implementation errors in future SAP Notes.
