## Reason and Prerequisites

The issue is caused by a requirement that was not covered in SAP Note 2302317 (SLD: legal changes for public sector - 601 to 611 concept change for new hired officials and removal of concept 563 for munpal employees).

## Solution

From now on, the concept 563 will be removed from the report in the cases where the Código de Cuenta de Cotización (CCC) type of the company assigned to the employee in the **Seguridad Social (ES)** (0061) infotype is in the range 15\* (e.g. 150).
