## Symptom

You are running SLD: fichero de bases(RPC\_PAYES\_CRETA\_BASES) report for an employee who contributes to FOGASA (Fondo de Garantía Salarial) or unemployment (Desempleo) and has the contribution percentages configured in the Seguridad Social (ES)(0061) infotype:

- Porcentaje de Desempleo pluriempleados (P0061-PLPDE)
- Porcentaje de FOGASA pluriempleados (P0061-PLPOR)

The RPC\_PAYES\_CRETA\_BASES report does not generate the BASE DE DESEMPLEO(701) or the BASE DE FOGASA(702) concepts.

## Reason and Prerequisites

SAP Note 2297708 did not deliver the correction to report the 701 and 702 concepts in case it has the same value from 601 concept.

## Solution

Corrections to source code of RPC\_PAYES\_CRETA\_BASES report has been provided to solve this issue. Now, the report correctly identifies whether 701 and 702 concepts need to be reported or not.

Additionally, both concepts have been reconfigured inSLD bases: fichero XML (CREB) sub application of the Asignación claves concepto nómina a CC-nómina acumulación (V\_T596I) view.
