## Symptom

At this point, a syntax error might occur when activating object MP339300. You can ignore this issue, since this will be fixed by the end of step 3.

3. Apply the infotype and report notes in the following order

- 2184284 - SH: Utilities classes for Status Handler Framework
- 2184579 - SH: Creation of Infotype 3393 for Status Handler Spain
- 2184688 - SH: Status Handler Framework

Do not activate the objects of these notes until all of them are implemented. Then, go to transaction SE38 and activate object MP339300. At this step, select all inactive objects that are shown and activate all of them together.

- 2180749 - SLD: Status Handler enablement for bases file report
- 2206566 - SLD: Technical enhancements to the enablement of Status Handler for bases file
