Symptom

You run the Informes de I.R.P.F.(RPC190E0) program for an employee who has work incapacity benefits (Prestaciones de Incapacidad Laboral Abonadas) during a month that has split payroll results and the BI Prestaciones (/164) wage type in the payroll cluster. The retention amount of work incapacity benefits of all splits of the month are being reported with the retention amount of the first split.

Example:

An employee has a payroll split in July of 2016 caused by any reason. During the second split of this month, this employee had 19 days of Incapacidad temporal(IT) absences. The payroll cluster of this employee has the following status:

In period	Begin date	End date	Benefits amount (/164)	Tax percentage

For this scenario, the RPC190E0 program is expected to report a benefits retention of 150,00 EUR (10% of the 1500,00 EUR):

But instead, it is being reported with a retention of 0,00 EUR as it is only using the benefits amount from the first split (10% of 0,00 EUR):

Reason and Prerequisites

During the adjustment of benefits retention by the RPC190E0 program, the /164 wagetype from the first split is being used by all other splits of the month.

Solution

Corrections to source code of RPC190E0 program have been provided to solve this issue.

From now on, each payroll split will use its own wage types when adjusting the benefits retention.
