Symptom

You run the Cálculo de nómina española (RPCALCE0) report for a part time employee with an absence and without a legal guardianship. The employee is treated as a full time employee with a legal guardianship, so the daily regulatory base (BRD) is incorrectly calculated.

Reason and Prerequisites

This issue is a side effect caused by the solution delivered by SAP Note 2363596. The Tipo de jornada para cálculo de BRD en caso de IT (ESS01) feature receives the Tipo de jornada del contrato antes de guarda legal (GUARDL) parameter with the Completa(C) value.

The following Support Package level is the minimum prerequisite:

Solution

Now, when the employee does not have a legal guardianship, the parameter GUARDL of the feature ESS01 receives the initial value.
