Solution

Corrections to source code of RPC_PAYES_CRA report have been provided to solve this issue.

After this Boletín RED, the Versión sint. mens (P_SMTVER) field should not accept the value '1'. Otherwise, the CRA file generated by the report may be rejected by the government. So, message El mensaje CRA puede ser rechazado si la versión de mensaje es &1.(5E696) has been created in order to warn the user about this.
