Symptom

You may face one of the following symptoms in the Datos fiscales (E)(0062) infotype in the New Infotype Framework (HR Renewal):

1. You display or edit entries with date prior to 2002 and after 2002, and the currency in the entries after 2002 are incorrectly displayed with currency equal to Peseta española (ESP).
2. You edit or create a Datos Fiscales (0062) infotype entry for an employee from Ceuta(51) or Melilla (52) regions, and the Rend. irreg. reduc. por empleado (IRREG_INC_REDUC_REQ) and Año con rend. irreg. reducidos (IRREG_INC_REDUC_YEAR) fields are not being displayed.

Reason and Prerequisites

1. The currency fields in the infotype screen were set in the Asignación elementos datos p.determinar textos fijos (V_T588FIX_TEXT) view to be filled by the New Infotype Framework automatically. However, the framework was reading the currency only for the first entry, so that any other entry had the currency set as the same as the first entry, even when the currency had changed in the Moneda del sector público (T500C) view.
2. The fields IRREG_INC_REDUC_REQ and IRREG_INC_REDUC_YEAR should be displayed for the Ceuta(51) or Melilla(52) regions. The SAP note 2361769 delivers this change for the Module Pool of the 0062 infotype.

Good to know: when you install an SAP Note, some prerequisites might be required. The prerequisites are SAP Notes that were already released and that change the same context of the current SAP Note. So, even if these prerequisites are not necessarily related to the symptom of the current SAP Note, you should implement them due to technical reasons.

Solution

1. From now on, the currency fields will no longer be filled automatically by the framework, and the CL_HRPA_UI_CONVERT_0062_ES class will be responsible for filling the fields with the correct currency.
2. The fields fields IRREG_INC_REDUCE_REQ and IRREG_INC_REDUCE_YEAR will be displayed for the Ceuta(51) or Melilla(52) regions.

Good to know: during the piloting phase, this SAP Note may be updated and versioned depending on feedback from pilot customers. After this SAP Note changes to status Released for Customer, it will not be changed anymore, unless there is a very specific situation that demands changes. If this is the case, a reason for the change will be specified in the SAP Note.
