Symptom

When you generate the Deduction Certificate (Certificado de Retenciones) 0005 (Hacienda Bizkaia) in the Informes de IRPF(RPC190E0) report, the reduction amount is being wrongly reported.

Reason and Prerequisites

This issue happens because the reduction of all irregular incomes of an employee were being summed and reported with the monetary payments (retribuciones dinerarias), which was causing this reduction to be reported twice.

Good to know: when you install an SAP Note, some prerequisites might be required. The prerequisites are SAP Notes that were already released and that change the same context of the current SAP Note. So, even if these prerequisites are not necessarily related to the symptom of the current SAP Note, you should implement them due to technical reasons.

The following Support Package level is the minimum prerequisite:

Solution

From now on, the reduction field will be reported according to the irregular income integration percentage, causing its sum to not be reported with the monetary payments anymore.

Good to know: during the piloting phase, this SAP Note may be updated and versioned depending on feedback from pilot customers. After this SAP Note changes to status Released for Customer, it will not be

changed anymore, unless there is a very specific situation that demands changes. If this is the case, a reason for the change will be specified in the SAP Note.
