Symptom

You run the SLD: fichero de bases (RPC_PAYES_CRETA_BASES) report for an employee with partial strike, contributing under the minimum monthly amount. The Spanish Social Security rejects the file with the following error messages:

- C9626 , BASES AT. INFERIOR AL MINIMO
- C9626 , BASES C.C. INFERIOR AL MINIMO

Reason and Prerequisites

You have to apply SAP Note [2503919](#) - CALC: New wage types for contribution bases in days of partial strike (/3H0 and /3H1) as prerequisite.

For each contribution group, the minimum hourly contribution amount is not exactly 8 times smaller than the daily contribution amount. When an employee works 8 hours a day but have 1 or 2 hours of strike, they should actually contribute a greater amount than if they would work for the whole day. Therefore, distributing the contribution amount of the month proportionally to the number of days lead to a contribution amount below the minimum according to the number of worked hours.

Good to know: when you install an SAP Note, some prerequisites might be required. The prerequisites are SAP Notes that were already released and that change the same context of the current SAP Note. So, even if these prerequisites are not necessarily related to the symptom of the current SAP Note, you should implement them due to technical reasons.

Solution

Now the contribution amounts of the /3H0 (Bas.cot.huelga parcial CC) and the /3H1 (Bas.cot.huelga parcial CP) wage types are reported for the partial strike days.
