Symptom

You maintain a Datos de mensaje FDI (0768) infotype entry with Estado reporte (REACT) Reportar parte de confirmación (3) in the New Infotype Framework (HR Renewal). This entry relates to an Absentismos (2001) infotype entry that is a relapse of an entry already reported by the FDI with Reportar parte de baja(2) REACT. The Fecha de la baja (FECON) field is filled with the begin date of the original absence.

Solution

Corrections to source code of CL_HRPA_INFOTYPE_0768 class have been provided to solve this issue.

Now, when there is already an AFI entry with REACT = 2 for the original absence relapse, the FECON date is the begin of the new absence.

Example: an employee had a non-industrial accident in June 11 until June 13. You report a leave confirmation for this period. Then a relapse occurs in June 14 until June 15. You report a confirmation from June 14 until 31.12.9999. When setting the Fecha de la baja (P0768-FECON), the date reported should be June 14.
